2020 Donor Agreement
Rules, Regulations, Procedures, & Covid Protocols.**



(*Sacred Waters CO, Inc. 501(c)7 and Sacred Waters CO Foundation 501(c)3 Tax-Exempt Non-Profit Organizations are Equal Opportunity Employers and Service Providers working through Special Use Permits from USDA San Juan National Forest Pagosa District and the State of Colorado. Licensed/Permitted, Bonded & Insured Outfitter in Colorado #OUT.0003217 *)

Use of any Ranch by Donors only (hereafter referred to as "Donor"). Donor shall use Ranches only for the following purposes disclosed in this Donor Agreement.

1. **Agreement Adherence.** Donor agrees to be bound by the Donorship Agreement as well as any directives from the Club Director and/or Guides. Any violations of the Donorship Agreement or directives of the Club Director and/or Guides for safety and enjoyment of another Donor may result in termination of Donorship. Any incidents will be reviewed and voted on by the Board of Directors. These incident decisions cannot be appealed and are final.
2. **Donorship Fees.** Donorship fees are refundable or transferable upon Board of Director review. The Club has the right to terminate, revoke, suspend any Donorship based on Board of Director decisions.
3. **Donor Benefit Levels.** Contributions at certain levels receive thank you benefits to donors. Benefit levels are set by the Board of Directors and are subject to change based on their discretion at any time. Benefit levels are defined in Addendum A.
4. **Ranch Usage.** Use of any Ranch for any other purpose is strictly prohibited without express consent of Club Director. Donor further acknowledges that some of the lands/ranches are used for livestock ranching operations and can be used frequently for hunting. Recreational activities in addition to fly fishing may be allowed upon request to the Club Director.
5. **Sportsmanship.** Donor will fulfill the obligations and purposes of the Club including highest level of good sportsmanship and ethical standards and will not willingly do anything to do any harm to the Club's existence and/or the Club's resources.
 - a. Donor/Guest must support and endorse the Sacred Waters Mission Statement. *
 - b. Donor/Guest shall discard any litter created or found immediately. If you are unable to dispose of it, bring it to the attention of the Guide.
 - c. Donor/Guest shall not cause any pollution or contamination (including the introduction of Zebra or Quagga Mussels or any other live or non-native organisms) to a Ranch or the surrounding area. Donor/Guest shall take reasonable precautions against the introduction and spreading of aquatic nuisance species of plants, animals and other organisms and shall apply all rules requiring effective equipment hygiene (drain, clean, inspect and dry policies).
 - d. Donor/Guest shall not create any nuisance, disorderly conduct or other activities which annoy/disturb any occupants of an adjacent or adjoining properties or other individuals. Be mindful of voice volume in respect to fellow group Donors.
 - e. When on a Ranch, Donor/Guests who exhibits intoxication will be asked to leave the Ranch. Repeated offenses will result in Donorship termination based on Board of Directors determination.
 - f. All pets must be retained in a vehicle, on a leash, or under voice command. If a Guide observes a pet becomes a nuisance, they will be asked to be removed from the property. Pet allowance approval must be obtained from Guide and/or Club Director prior to trip.
 - g. Children under the age of 18 must remain under the supervision of a parent.
 - h. No swimming, diving allowed on a Ranch. There is no lifeguard on duty at any time.

6. **Guests.** Donors may bring no more than three (3) fishing guests per day. Corporate Group Events must contact Sacred Waters for details. Max no more than twenty (20) guests.
 - a. Children under the age of eighteen (18) are not considered guests.
 - b. Guests actions are sole responsibility of the Donor.
 - c. Guests are not permitted on a Ranch unless accompanied by a Guide and Donor at all times.

7. **Guest Accountability**

Donor agrees they are their solely responsible and liable for the actions of any/all Guests that the Donor brings to a Ranch.* Guests of Donors are required to sign, in their individual capacity, the Donor Agreement, Waiver and Release from Liability before joining a Donor to any Ranch.

* See Club Donor Liability Waiver for further details.

8. **Photography**

Donor agrees that both commercial and non-commercial still photography, audio/video and/or motion picture photography may occur during Donor or Guest is present at a Ranch. When in the general area, a Donor or Guest may be incidentally be included in such photography and recordings. If you wish to be excluded from such photography and/or recording, then it is your responsibility to be aware of photographic activities and should promptly exit the area being photographed or recorded. Donors and Guests hereby grants Sacred Waters it's agents, guides, volunteers, sponsors, beneficiaries, heirs and assigns the right to use Donors and Guests' photographic image and audio/video recording(s) in the promotion of Sacred Waters and its associated activities in general as it chooses in its sole discretion without compensation.

9. **Fishing Parameters.** Donor acknowledges that the benefit privileges granted by a Donorship in the Club are for fly fishing with Catch and Release at a Ranch.
 - a. No more than eight (8) individuals shall be permitted to fish at any given Ranch in a 24-hour period. In addition, no more than four (4) float trip individuals in a 24-hour period.
 - b. Other than the restrictions defined within, all Colorado Parks & Wildlife fishing restrictions shall be observed.
 - c. Fishing is allowed one half hour before sunrise until one half hour after sunset.

10. **Ranch Requirements.**
 - a. All personal property must be removed from a Ranch at the end of each day.
 - b. Use of artificial light is prohibited on a Ranch.

11. **Firearms.** No discharge of firearms, weapons, or fireworks of any type are permitted on any Ranch without advance Club Director's permission.

12. **Motorized Vehicles.** Only with Guide approval can a Donor use motorized conveyance of any type at any Ranch is strictly prohibited to area outside any established roads and/or parking areas. This restriction does not apply to motorized vehicle access necessitated by life-threatening emergencies.

13. **Camping.** Platinum Donors have access to designated camping areas. Platinum Donors must email or contact the Club Director (or Designee) for reservations and details.

14. Scheduling. Sacred Waters strives to provide each Donor and Guest the highest quality outdoor experience as reasonably possible.

- a. Sacred Waters reserves the right to make schedule changes.
- b. Reserving trips is on a first come, first served basis.
- c. An availability calendar is accessible on private password protected web page that Donors will receive via email after Sacred Waters receives your signed contract and payment.
- d. To book a guided fly-fishing trip please use contact form on Calendar Webpage or call Sacred Waters at (970)444-2187 or (970)731-1443.
- e. Sacred Waters reserves the right to host private non-profit events throughout the season. All Donors will be invited to participate in private non-profit events.
- f. Sacred Waters shall have the right to cancel a reservation if any water quality rules or regulations applicable to a Ranch make it impractical for Sacred Waters to continue to lease such Ranch. If there is a cancellation for such reason, Sacred Waters will provide a fair and equitable refund for any portion of a Ranch use reservation or current usage or recommend an alternative location.

15. Rules and Regulations.

- A. Sacred Waters reserves the right to modify and make additions to Donorship Rules, Regulations and Procedures as necessary in order to maximize each Donors' and/or Guests' experience while utilizing any Ranch.
- B. The Club will provide Donors with any amendments or additions to Donorship Rules, Regulations and Procedures via Email and Website. No further actions will be necessary for the amended Donorship Agreement to be binding and effective on every Donor and Guest upon their circulation.

Covid-19/Corona Virus Pandemic Protocols for Sacred Waters CO, Inc. & Charity Foundation

June 2020

- As of May 27th, 2020 (CO state legal reopening of Outfitters), Sacred Waters CO, Inc & Charity Foundation Staff were delaying operations of Guided Fly-Fishing Trips and/or Group Events as the state of Colorado is slowly easing restrictions, and opening businesses/services.
- We at SWCO are going to continue to watch the Covid-19 Data to determine what happens as restrictions ease up and businesses/services open. If Covid-19 cases stay neutral / flat or decline for 30 days as of 04/27/2020 we will begin to operate and offer services any rise in cases we will remain closed for business until the curve of cases is flat/neutral or falling/declining for more than (2) weeks.
- All Sacred Waters CO Guides &/or Volunteers will adhere to all Federal, State, County, and local safety guidelines, and restrictions. Sacred Waters CO Staff have been and will regularly check and/or be updated of any/all changes to these restrictions, rules, protocols as relative governmental agencies update.
- As restrictions/rules concerning Covid-19 change throughout this pandemic all Sacred Waters CO guides will be updated and given hardcopy printouts of said changes.
- All Clients/Donors/Guests will be informed of all Covid-19 safety guidelines and restrictions while in communication of trip booking/scheduling, 24 hours prior to guided trip and while meeting with guide for trip as well as throughout the trips as needed.
- Guidelines/Protocol at present June 2020 for Guided Fishing trips with Sacred Waters CO. we will screen your guides and you (clients/donor/charities) before a trip and ask if they
 1. Do you feel/are sick?
 2. You have been in contact with someone sick?
 3. You have traveled/been in areas with high Covid caseloads?
 4. Have you been tested for Covid? When? Results?
 5. All participates and staff will adhere to Social Distancing Guidelines of a minimum of 6 feet of separation while on a guided fishing trip.
 6. Clients and Guides will transport their selves in separate vehicles to fishing location.
 7. Guides will use long handled fishing net to keep farthest separation of guide & client.
 8. Guides will wear face masks (nose & mouth coverings), clients will be asked to respectfully do the same.
 9. Lunches/Meals provided by Staff to Clients will be pre-packaged meals from a grocery store or restaurant (NO handmade/homemade Meals)
 10. Guides always and will continue to provide Anti-bacterial Hand Sanitizer and use regularly. With emphasis of use by Guide & Client when needing to hand over/exchange/transfer items like fishing equipment, fishing rods, nets, cameras, cell phones, food &/or drinks, credit cards or cash, ink pens, paperwork(contracts, liability waivers) etc...
 11. Any borrowed equipment provided by Sacred Waters CO. &/or SWCO Guides will be regularly sanitized/washed (daily before & after use) fishing equipment, apparel, ink pens, etc...

(Sacred Waters CO, Inc. & Sacred Waters CO Charity Foundation reserves the right to refuse service/s to anyone who may not meet current Covid protocols &/or who will not comply with all above mentioned protocols. Thank you for your understanding & cooperation.)

Glossary of Terms

Donor: the person whose name is on the Donorship agreement. One individual per Donorship is allowed.

Guest: any person other than the Donor listed on the Donorship. They are treated as a temporary Donor for their visit and are accountable for all Donor Rules, Regulations and Procedures.

Guide: the person who accompanies you to a Ranch location

Ranch: any given property which is leased/owned by Sacred Waters with the explicit permission of the land owner

Club Director: the person who coordinates any/all Donor and non-profit activities

Board of Directors: the group of individuals who are responsible for Sacred Waters executive decisions and directives.

Sacred Waters Mission Statement

Our mission is to protect and support the health of waters, and the ecosystems that they feed, through conservation, advocacy, rehab, and education.

As an Officially Registered IRS Tax Exempt 501 c3 Charity Foundation & a 501 c7 Social Club in Southwest Colorado we recognize the limited resource we have in our waters and strive to improve our local fisheries by working with landowners, clients, guides, news media, and land management agencies to help sustain aquatic habitat and to protect our irreplaceable awesome fisheries.

At Sacred Waters CO Foundation, Inc., & Sacred Waters CO, Inc. besides our work restoring river habitat, we have a big spot in our hearts for helping veterans recover from the tribulations of war, as well as fostering a love for fishing and the outdoors in our youth.

The four pillars of our organization guide how we operate and give back as a nonprofit.

Conservation - We are protecting all waters, which means working with public land management agencies and private landowners alike. Our protection and maintenance efforts in a small fish habitat will bring prosperity beyond the immediate area. Improvements to fisheries and river habitats, no matter how small and regardless of whether publicly or privately owned, benefit the entire river.

Advocacy - The word 'advocacy' takes its roots from the Latin 'ad vocare' meaning to speak for someone.
